- **56.** The area you denote as "Downtown" has never been so.To think that you can create a "Marketplace" type area from an area already ruled my minority gangs and semi=poverty is illogical.

Moreover, I'm hesitant to throw my support behind a makeover of downtown Bakersfield with the Mill Creek Project & mixture of housing, retail, and commercial because of the potential upfront cost to City (i.e., if private developers do not want to pay the existing owners for their property, then the City may seek to pursue via eminent domain under the auspices of "Redevelopment" and resell to the private developer like they tried to do a few times before in this area -this approach is highly unfair to the existing owners and I'm sure will bring on several lawsuits.). I think a Federal Courthouse is absolutely necessary, given the population/size of Bakersfield and its environs.

- **82.** Downtown should be just what it is, downtown. No housing is needed downtown. Downtown should be a pleasant place to visit. There should be big shops, small shops, ice cream shop, candy shop, small dining, fine dining. Something for everyone is needed downtown.
- **83.** MIxed use development. Increased public transport options. Infill development. Higher density development. Walkable and bikeable neighborhoods. Active Community Environments as recommended by the CDC. All extremely important to a sustainable future for our city.
- 84. Clean up and revitalize the downtown by creating less opportunities for bums to hang out, loiter and

- **88.** I am not sure what the Mill Creek Project is. I believe the river banks should be preserved as parks. The areas adjacent to the river should be used as jogging, bike riding and horsetrails, although something like the Riverwalk in San Antonio would be a valuable addition to the city. However, we live in a desert, and we should not be using our water for "looks". However, if we could get some recreational use out of the water as it moves toward the aquifer recharge areas without polluting that water, that would be a great. I do not see why we need 24 hour parking downtown. I think we have too many bars now that are open too late. We do need more parking for jurors and for shopping, but I do not think the demand is that great. I would like to see the downtown retooled for residential.
- **89.** Downtown should be a place accessible to pedestrians and an area of interest to all: specialty shops, museums, comfortable settings to rest, eateries of various etnic cuisines, designer wares and furniture, bookstores, while government is better located outside the downtown area and altogether where there is parking without meters, like San Jose. - **115.** Revitalization of the downtown area is of utmost importance in unifying the city as a whole, wich will help to continue the "small town" community atmosphere.
- 116. I feel that it is very important to maintain the small business and antique housing feel to the Downtown area. I am extremely opposed to any modern "Southwest Bakersfield" housing in the downtown area. We have acres and miles of boring track housing in Bakersfield. No more housing developments destroying the charm of the lovely downtown area.
- 117. The parking situation downtown is a major detriment to attracting people to visit that area. Most of the parking spaces only allow 30 minute parking, which is insufficient for shopping, dining, or government business. I don't know if it needs to be available 24 hours, but 2 hours at a time would be an improvement.
- 118. Our city leaders need to open their eyes to how minorities are mistreated in Bakersfield. I would like to see fewer new homes being built, better access via roadways from the west to the east side of Bakersfield, and more equity in how decisions are made by our government officials. The downtown issues effect a minority of people of Kern County. If you are not a county, city or state employee, the only other business during the day on a regular basis is if you need to go to the court. Why should 100% of our population be so concerned about issues that effect so few?
- **119.** Have some kind of shuttle service instead. Park the cars farther away.

- **123.** More high rise condo type housing needs to be built downtown and city streets open to foot traffic only to create an outdoor mall effect on the side streets.
- 124. Downtown is NOT IMPORTANT!!! there is nothing special about downtown, no more so than any other part of town. If downtown (by this I mean its property owners) cannot attact people to shop downtown by themselves then NO PUBLIC money should be spent trying to force people to shop there, period. Downtown is no more 'historic' and no more deserving of public money than any other part of town. In fact, since downtown is not the center of town, public building should not be located there. They should be located closer to where most of the people live.
- 125. River through downtown should accommodate covered pedal boats for exercise and practical transit with cargo (such as backpack, food, etc.). Would be nice to connect the river access to Kern River Parkway facilities. Since there is difficulty traveling east-west in Bakersfield by bicycle, a path/river that traverses downtown through Old Town Kern and East Bakersfield would help revitalize the East Bakersfield area and promote healthy activities. Riverboats like in San Antonio would establish new lifelines and boundaries, reduce dependency on cars and provide access for local residents.
- **126.** I do not feel that it is a wise use of funds to divert water to create a river street in the downtown area. This money should be used for maintaing the surface streets instead.
- 127. I am not familiar with the particulars of the Mill Creek Project. There was no other box to check.
- **128.** I love what I see happening to Downtown Bakersfield. We need to get the Padre Hotel project going again. It is a beautiful landmark. It needs to be part of the Downtown revilization.
- **129.** Make downtown more bicycle friendly with additional bike lanes and class I bike trails. Add high density housing with enough surrounding shops, restaurants, and entertainment to make it desirable.
- **130.** I think our downtown is okay -- but it does not draw me to the area for regular shopping, dining, or entertainment. When I think of an exciting downtown, I envision those of older college towns, with upscale shops for cooking, decorating, books, clothing boutiques, etc. We have a few of these types of businesses downtown, but they are spread out and not centrally located. That means I must drive to one location poke around, get in my car, drive to another location and look for more parking. I think more downtown living would encourage businesses to be where people were. It could even include a consistent nightlife scene.
- **131.** I think the Mill Creek project will revitalize downtown and create a tourist area similar to San Antonio Texax.
- 132. I know they are unattractive, but parking garages would be great!
- 133. I love the downtown area and would love to see it used. I hate when the downtown area gets a bad rap from a bar fight/stabbing. I have been in Bakersfield long enough to know these things happen all over and not just downtown.
- **134.** If the housing is upscale appartments and condos for people working in the dowtown area.
- 135. Don't even think about Downtown development without thinking about a drastic improvement in road infrastructure
- **136.** Put in adequate guardrails on Panorama Drive and the roads to it so that no one else is killed driving over the cliffs. Very important.
- **137.** FREE parking. Downtown must be made more accessible.
- 138. Some type of linear park, potentially linking several areas with a pleasant, walkable greenspace, sounds like a good idea. However, an artificial river appears to present a set of large resource-intensive challenges. If you want water, why not a series of fountains?
- **139.** Why not improve what we have in place. Why spend tax money on down town rivers, etc? WE have enough of those type of projects in place. The ones where people say, "is that what they're spenting our tax money on"...
- Parking is important because of the absence of a public transit system (i.e. metro, subway, BART). It is probably premature for this type of transportation but provisions for future construction should be made. If Downtown becomes a big draw it will be critical.



- **141.** MORE HOUSING DOWNTOWN. I was forced to move out of downtown because of a lack of housing. Condo highrises would be very attractive. Also, More parking garages and _less_ parking lots. all the empty space created up the lots detracts from downtown.
- 142. Mill Creek is a total waste of water. It will breed mosquitos. It has the potential to raise the water table to unsafe levels (liquifaction) and recharge groundwater that is already miserably contaminated with MTBE, dry cleaning solvents, nitrates and God knows what else (reference RWQCB). Leave the water in the Kern River or the existing canals, where it belongs.
- 143. We had a Federal Courthouse. The City and County allowed it to be sold at auction to Tom Carousella!
- 144. A federal courthouse is important for the community, but not necessarily for the downtown area.
- **145.** consider parking garages--for shade and greater use of space
- 1 suggest creating a link pedestrian and bicycle friendly link between downtown and the Kern River Parkway. One idea is to build a class one bike path along the Santa Fe railroad track rights of way--- Chester Ave to Kern River Bike Path. Another link would be to create a bridge and bike path into and around the Kern County museum area. How a; bout a path along the widening and wall blocking of the future 24th street (rosedale, 78) through Westchester to downtown. How about all three routes, in phases?
- 147. Federal Courthouse will need adequate parking that will support some retail. Some sidestreet parking in downtown creates a safety issue as the street is very narrow (H & F St). Need better parking near the FOX
- **148.** PRotect the old buildings and keep their antique facade. Make heritage sites. Bring in more restaurants than bars. And don't waste money on things like a downtown trolley rather give tax incentives for businesses to open up in the downtown rather than in the developing outlying areas.
- **149.** The heart of Bakersfield needs to be where it belongs...in the heart of Bakersfield. We need a vibrant alive city center.
- 150. The Mill Creek Project sounds interesting, but I just don't get it?
- **151.** Need a river walk like San Antonio!
- The mill creek project planning is not being performed in a manner that brings an adaquate perspective on the overall economic impact it will have on the public. To my knowledge, cost-benefit analyses are not specifically required in the city, and are not totally comprehensive in the county as a part of the EIR. I think that the evironmental considerations are important, but the long-range economic and social impacts are net being appropriatly considered for new development/growth elements. I understand that the local fiscal responsibility of taxpayers will be at least \$2 mil. in addition to the matching funds required, plus the other incentives given to the developer. I'm not saying that this should stop Mill Creek, but let the taxpaying public see the total economic impact that will be created by Mill Creek. And, of course, this has to do with the entire planning/growth process. We are not being informed. The planning processes are carefully and clandestinely ongoing with a brief exposure at the rubber-stamping Planning Commission. At times I wonder why we even need a Planning Commission after I attend its meetings.
- 153. Would like to see the downtown area less congested with vehicles and more pedestrian friendly.
- i suppose this is to attract more businesses to bakersfield area. however, we remain, at best, an enormous small town. i have waited and listened for over 50 years hoping for positive changes and have seen ideas come and go with nothing changing. we cant even decide on long overdue freeways. a recent trip to sacramento made me realize where we could and should be in terms of a more modern and cosmopolitan city. our overzealousness in our conservative background leaves us hopelessly mired in the small town quagmire. city leaders, please help.
- **155.** In implementing future changes, one very important addition needs to be APS (Accessible Pedistrian Signals). These are of vital importance to blind/visually impaired citizens.
- If these are your only downtown strategies, your in trouble. Development of a mixed use is pleasant, however the strength of a downtown area is predicated upon its commercial, retail, office, and governmental development. While these are developing, circulation, open spaces, and service utilities must be taken into account, not an afterthought. Water flowing through the city is pleasant, but always the liability. The drain for the fountain at the Civic center is a case in point. I would like to see a more master planned downtown developed instead of letting every little piece of this and that happen whenever or wherever possible. Set aside a commercial district, professional office district, retail district,



- etc.... with open spaces, corridors for walking or people movement from place to place... why wait for someone to tell the city what they want to have, tell them what the city wants instead.
- **157.** I love all the different places downtown. I notice a lot of youth like to be there on weekend nights there should more places for them to go downtown so they will not get into trouble.

- 166. I work downtown and would love to see it have a more mature nightlife.
- 167. "Downtown" confuses me. I was told it is where Montgomery Wards was. "Downtown" in most cities includes government buildings, department stores, and generally a point of interest. Bakersfield doesn't have this. I go "downtown" to see a doctor or visit a government facility. I have yet to go "downtown" to shop. I go to Valley Plaza on rare occasions, or I go to Rosedale. A vision should include where your housing will be (variety). Where the commercial area will be. And, where your medical center will be. I think that east of Hwy. 99 is an area I don't want to venture into. The west side has such a mixture with commercialism on every mile road (except around Grand Island). I have spoken to or emailed two supervisors about a revitalization plan that I have seen this summer while visiting Indianapolis. I do have pictures of the homes they built and what a difference. A city that was about the size of Bakersfield, when I grew up there. That city has a vision. It has included a "ring road" around the city and a highway that goes thru the city. You need to consider "in fill" with your building. Plan your city. I see a hodge podge. Whatever a builder wants you let them build. Size of homes, cost, color, parks and CC&Rs should all be required. The ugly tourquoise car wash with it's bright yellow lights at Calloway and Brimhall that backs up to my housing should never be allowed. You have the capabilities to demand a certain level of 'elegance' to a neighborhood. Our home values are not reflecting the neighborhood. The 7-11 and the Rite Aide are all precusors to more commercial building at Brimhall and Calloway. Why would you do that to your city. Property values will not hold and when values go down so will your taxes. Please consider how you want your city to look in 2020. Like Camarillo, Thousand Oaks or like L.A. How many of you have been outside the state of California or for that matter - outside the City of Bakersfield and really looked at other cities. The fast train you want to stop in Bakersfield will serve very few people. Compared to good highways that can serve the majority of people. New government buildings do not serve the general public. It serves only a few working people. You also need to have more activities for teens. There really isn't a lot to do here. So make a plan that will encompass all the needs for all the citizens. Think twice about where the money is going.
- The downtown area needs retail and customer friendly environs, not housing. The exception to that would be highrise condo's with great security. The proposed 780 unit housing development along the Mill Creek proposed development is in the wrong place. This will only CREATE A FUTURE GHETTO. Traditionally, housing along railroad tracks and transportation hubs has a lower value. The area is not zoned for housing for a reason! This housing project should be on the South side of California Avenue, which is in the Southeast Redevelopment Area, is already zoned for residential use and has a dire need for redevelopment. The area between the railroad, Q St., Truxtun, California and Union Avenues should be designated as a Commercial, Business and Entertainment area, creating a buffer zone between the transportation area (railroad, Amtrak,future High speed Rail station, high speed rail, and future highway) and the residential area. The majority of high use customers of these transportation modes will be from the business community. Any urban planner or design professional knows the reasons for this traditional planning discipline. Better planning and attention to the realities of Urban Development are needed to

- implement a truly great vision for downtown Bakersfield.
- 169. I think Bakersfield or I should say California in a hole waist to much of the tax payers money...
- **170.** Downtown has many activities now yet little interest from the community. Focus the resources elsewhere.
- **171.** Reliable and guick public transportation connecting downtown to the rest of the city.
- 172. I think we need to look more at building a new baseball stadium. We built the new swimming complex and ice skating rink and that was a total waste of money. That money could have been used to build a stadium that could be used for several different venues. Instead we get a swimming pool and an ice skating rink that I can assure you, most of the people in Bakersfield will never use.

The city should work with businesses to assist in and encourage rebuilding projects in the downtown area, but not take on the ownership and operation of the redevelopment. Let's give free enterprise a chance. Cut out the red tape and quagmire of city rules and ordinances. Work with business not against it.
